Course Description

Public Policy is an ever-evolving field with its various forms, models, elements, stakeholders and frameworks. This course aims to provide students with an understanding of the practical and theoretical issues of the public policy process specifically dealing with the Laswell's Stage Heuristic Framework that is famously known as Policy Cycle. The course would provide an in-depth understanding of India as well as the global policy making ecosystem. process by emphasizing the political nature of the process, i.e., how various actors' interests influence the policy process. It would also open a dialogue about the applicability of extant theories to India and possible ways to build theories that may be relevant to the country.
